WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., Supply and Delivery of Water Service Connection Materials and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of TWO MILLION TWO HUNDRED NINETY EIGHT THOUSAND SIX HUNDRED NINETY EIGHT PESOS AND THIRTY EIGHT CENTAVOS ONLY (Php 2, 298, 698.38) (hereinafter called "the

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - the Schedule of Requirements; (b)
 - the Technical Specifications; (c)
 - the General Conditions of Contract; (d)
 - the Special Conditions of Contract; and (e)
 - the Entity's Notification of Award. (f)
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of
- The Entity hereby covenants to pay the Supplier in consideration of the provision of 4. the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
- In order to assure that manufacturing defects shall be corrected by the Supplier, a 5. warranty shall be required from the Supplier for Three (3) Years on Water Meter and One (1) Year on Fittings after acceptance by the Procuring Entity of the delivered Goods or after the Goods are consumed, whichever comes first.

The obligation for the warranty shall be discovered by either in a form of cash or cashier's/manager's check issued by a Universal or Commercial Bank or Bank draft/guarantee or credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank equivalent to five percent (5%) or surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security equivalent to thirty percent (30%) of the total contract price. The said amounts shall only be released after the lapse of the warranty period: Provided, however, that the goods supplied are free from

patent and latent defects and all the conditions imposed under the contract have been fully met.
